#### **General Information:**

Windswept Farm Agility would like to invite you to an AAC (Agility Association of Canada) Sanctioned Agility Trial.

Trial Format: Regular format on an indoor ring.

<u>Title Trial</u>: Regular, Special and Veterans classes will be offered as required.

<u>Dog Collars</u>: Dog will be allowed to wear a close fitting collar, with no attachments. (new rule 1<sup>st</sup> Jan 2021)

Senior/Disabled: Accessibility division with concessions for seniors (65 years and older) or disabled handlers may request a

modified course time and a modified point requirement. A handler must indicate on entry form if entering as a senior/disabled handler (check SD box) to receive modified times/reduced number of points. (new rule

1st Jan 2021)

Obstacles: Flexible Tunnels, Breakaway Tire Jump, Ascending Spread Jump, Double Bar Jump, Single Bar Jumps, Dog

walk, Weaves, A-frame, Teeter.

<u>Facilities</u>: The trial will be held <u>indoors</u> on sand. An outhouse is available at the back of the arena. Please use hand sanitizer

before entering and when exiting the outhouse. Hand sanitizer is provided.

Masks are encouraged but not mandatory at this time.

No food or beverages will be available for the duration of the trial

There are acres of land to walk your dog on a leash during the trial. We do ask that you poop-n-scoop and keep your dog on a leash unless in car or running an event. Please do not dewater your dog near, beside or in front of

arena.

Gate and arena door will be opened by volunteers.

There will be no leash runner for this event and competitors will be asked to 'drop and pickup' their own leash.

There will be a partition between waiting area and ring.

#### **Directions:**

#### Windswept Farm Agility: 3722 Woodkilton Rd, Woodlawn, Ontario

- From the 417 (heading towards Arnprior from Ottawa) take the Kinburn Side Road exit and go north-east on regional road 20 for approximately 15km till intersect Woodkilton Rd. Turn right (southwest) and destination is 600m on your left.
- An Alternative: From the 417 (heading towards Kanata from Ottawa) take March Rd north for approximately 8km to Dunrobin Rd. Turn right. Continue on Dunrobin Rd for 7.3km. Turn left onto Thomas Dolan Rd (traffic lights). Go 1.5Km. Turn right onto Woodkilton Rd. Drive 5.7km. Event is on the right side.

All dogs must have an AAC ID number to compete. Please email a copy of ID card with your entry form unless it's already on file. There shall be no refunds for entries withdrawn after the closing date or in the event that a dog and/or handler are dismissed from the trial, regardless of the reason, or in the event of inclement weather. Bitches in season (BIS) are not allowed onsite. Refunds will be issued for dogs that come into season or are injured, providing a veterinarian's certificate is received by the Trial Secretary within 48 hours of the trial date. Credit towards future trials will be issued if trial is cancelled due to new Covid-19 restrictions or inclement weather.
